With the increased sexual harassment, exploitation, and insecurity as well as unequal economic and political opportunities in Uganda, last week young women called for increased efforts in ensuring safe cities that facilitate for their participation in development processes. While taking part in the Youth Day Marathon organized on 11 August at Makerere Freedom Square as part of the build up activities to the Youth Day, they emphasized the need for safe spaces for realize their full young people to potential. "By running in this marathon, I am calling upon all citizens of Uganda especially our leaders to come up with mechanisms on how best to ensure that young people especially young women in tertiary institutions and workplaces are protected from sexual harassment", said Esther Tuhirirwe a young woman from Kampala. The event which drew more than 100 participants was officially opened by the Minister of Kampala Hon. Betty Kamya, who challenged young people to start thinking on how best they can ensure that spaces for youth are inclusive and safe. Global Platform Uganda supported 50 participants that came from the different parts of Uganda as far as Katakwi District. The platform will continue working closely with different partners in ensuring

that young people participate in policy dialogue discussions and they play leading roles in eradicating poverty, fight against social injustices and achieve sustainable development.

International Youth Day: Youth in Namutumba Advocate for Youthfriendly Health Services!



By Immaculate Awori Last week, young people in Namutumba District supported by Busiki LRP joined the rest of the world to commemorate International Youth Day under the theme "Safe Spaces for Youth". It was the first time of its kind in seven years that the youth were celebrating International Youth Day.

They engaged in cleaning the Nsinze Health Center 1V and planting trees. There was a dialogue after the activities where they had an opportunity to engage the government officials on health service delivery. One of the youth leaders of Nsinze Sub County stated that young people in Namutumba District are changing the narrative on young people who are viewed as lazy people and not engaged in developmental processes

"We would like to change the perception that youth are idle and only good at making noise. Today we want to give back to the community by cleaning our health center and planting trees", David Luke the youth leader of Nsinze Sub County. Some of the major problems that young people pointed out during the dialogue were lack of youth friendly services and youth corners, lack of information on available health services, understaffing, attitude of health workers towards young people, lack of essential drugs and instruments, charges levied on testing of hepatitis, limited lighting and water in some health centers in Namutumba District.

Apaa Community Cries Out to Land Commission for Intervention!

Omony Geoffrey held a meeting with Dr Douglas Singiza, the secretary to the Commission of Inquiry into Land matters to seek for a speedy inquiry into the Apaa crisis. On filing their case, it was considered urgent and made priority for intervention, which the commission promised to address within two months. This follows numerous failed attempts by the community to attain back their land from Ugandan National Authority. They have petitioned Government and the international community among others but all these have failed to support them in the struggle for justice, including camping at the UN offices in Gulu and having meetings with delegates of different embassies. There have previously been alot of calls from the Civil Society fraternity and government leaders for the Land Commission of Inquiry to prioritise the Apaa Land Conflict which has negatively affected thousands of people. AAU has courageously stood with the people of Apaa right from 2012 when the Government of Uganda gazetted their land as a National Park while the people were living in Internally Displaced Persons camps.

CSOs urge Government to pass the Mining Law !

Small scale Miners , CSOs and Members of Parliament questioned Ministry of Energy over the delay which has resulted into suffering and unfair treatment of artisanal and small scale Miners. "Why delay a law that is supposed to help exonerate mining communities? The people feed off mining and of recent many have been chased from the mines because the law does not recognise them! Fasten the law review process, and ensure that it gives back to host communities!" Hon Francis Mwijukye told the commissioner from Ministry of Energy; Eng Francis Kedi The Extractives Governance Cooridnator Didas Muhumuza reemphasized the need to hasten the law to help uplift the livelihoods of mining communities. He pledged AAU's willingness to work with Government to sensitize the miners on the online registration- a new form of registration that has been introduced by the Ministry to avoid bureaucracy backlog and Follow this <u>link</u> for more information.

AAU Conducts Regional Training on Taxation!

It was attended by AA Tanzania, AA Burundi and AAU partners The training revolved around gender responsive public services, tax treaties, progressive taxation and fair Tax Monitor. Participants discussed problems that cut across the entire region like the debt problem, heavy reliance on Foreign Direct Investments and corruption. Participants also had an opportunity to share experiences about tax systems in the different countries. The team agreed to undertake a regional study on taxation policies in different East African countries and share learnings by the next meeting slated for 2019.
