ActionAid in Solidarity with Palestine-End Occupation!

Last Monday, ActionAid stood in solidarity with the Palestinians to demand for an end of Israel occupation of their land and the right to self determination. Clad in white, Red, Green and black (colours of the Palestine flag), ActionAid staff held placards with messages demanding for an end to the 50 year old injustice.

During a solidarity dialogue on the Palestinian Occupation held in the Organisation's board room, Fredrick Kawooya, the Policy and Campaigns Manager at ActionAid informed staff that the Palestine- Israel conflict is not about religion as many tend to think but about land grabbing by the powerful.

"For half a century, Israel's occupation of the West Bank, including East Jerusalem, and the Gaza Strip has resulted in systematic human rights violations against Palestinians living there" he said adding that the last 50 years have seen Israel force thousands of Palestinians off their land, occupying and illegally using it to create settlements that exclusively house Jewish Israeli settlers.

"Their homes and livelihoods have been destroyed, they've had restrictions on their movements, water, land and other natural resources enforced on them. The communities have also been violently attacked by the Israeli military and settlers. As ActionAid, we exist to challenge such injustices and work for the restoration of lives of dignity" he challenged urging staff to do any action in their power to denounce these injustices.

Staff were however informed that the injustice can only end if our governments stop enabling the economy that keeps these illegal settlements growing hence fuelling the suffering of the Palestinians.

"The issue is not just about Israel taking Palestinian land and resources illegally. Governments around the world are letting goods produced in these settlements into their markets, and are allowing companies in their countries to operate in settlements. All of this is helping the illegal settlements to profit and thrive", he noted.

The dialogue ended with a photo action and commitment by staff to work within their ability to put pressure on World powers to put an end to the cycle of violations suffered by Palestinians living under Israel's occupation.

Since the occupation first began in June 1967, Israel's ruthless policies of land confiscation, illegal settlement and dispossession, coupled with rampant discrimination, have inflicted immense suffering on Palestinians, depriving them of their basic rights.

Israel's military rule disrupts every aspect of daily life in the Occupied Palestinian Territories. It continues to affect whether, when and how Palestinians can travel to work, school, abroad, visit their relatives, earn a living, attend a protest, access their farmland, or even access electricity or a clean water supply. It means daily humiliation, fear and oppression. People's entire lives are effectively held hostage by Israel. As one Palestinian puts it;

"The worst thing is the sense of being a stranger in your own land and feeling that no single part of it is yours"

The day's overall winner was Ms. Anne Mary Imoni, a midwife at Omatenga HCIII. Ann was recognized for her exceptional dedication to saving mothers and their babies during child birth at the health facility which she has managed for the last 8 years without any support staff.

The best performing politician was Ben Eumu, the District Chairperson of Ngora. While he hails from the opposition (FDC), Ben has managed to unite the people of Ngora to work towards developing their district. Mary Aigo, the AG-Head teacher of Awaliwali Primary school as recognized as the best performing civil servant in the Education sector. Under her leadership, the school performance in the primary leaving exams has exceptionally improved.

Other winners include Atim Mary, the District Education Officer of Katakwi, Odeke Valdo, an extension worker in Kumi,Opolot Kokas, a health worker and Dr Ongala Emmanuel.

Justice David Batema of the Soroti High Court congratulated the winners and urged them to keep only on the top.

"You have made us proud. Congratulations. You have set the bar so high for the rest of us" he said. Justice Batema challenged workers who are always blaming their tools to do their best within the current situations and leave the rest to the Government.
