Starting today 9th/07/2018, every Monday shall be a no-data-day to mark the beginning of Stop Social Media tax campaign.

ActionAid Uganda, SEATINI and other tax justice organisations under their umbrella body- Tax Justice Alliance, announced yesterday as they added their voice to the so many Ugandans to detest the Shs200 social media tax and 1% mobile money double tax. AAU's Campaigns Manager Fredrick Kawooya expressed his disregard for the tax on social media , for it is limiting access to information for especially the young people, while mobile money tax is kicking many out of employment.

"The number of people using mobile money has gone down- this was one of the biggest forms of employment and now many have been left unemployed!" he affirmed.

Mobile money transfer system is the biggest driver of financial inclusion. As of 2017, the UCC report noted that mobile money subscriptions stood at 23.6 Million Ugandans, with 61 percent transactions below Shs45,000. Kawooya thus confirmed that MM tax is going to hinder financial inclusion while SEATINI's Jane Nalunga declared that unless Government changes the way it allocates its resources, tax collection will continue to burden the poor while uplifting the rich.

What started as an order from the President, later turned law, may need repealing as the pressure among the country men and women towards the law makers increases daily.

On 1st July, a new tax was announced On Mobile Money and OTT services. Sadly this law was debated in Parliament and majority of the legislators voted in its favour, with the forecast of having their allowances as parliamentarians increased.

Since then, the countrymen went up in arms, mobile money agents across the country staged demonstrations while Member of Parliament for Kyadodo Hon. Ssentamu held a press conference with artists, journalists and social media influencers calling upon the public to desist the tax by abandoning use. In Soroti and Kampala, MM agents have been rioting while university students headed by Makerere University are meeting the Speaker to explain this action.

Minister makes case for cooperative Bank

By Brenda Namirembe: The Minister of Finance, Hon. Matia Kasaija has urged Cooperators to have their cooperative bank that once existed revamped for friendly loans.

He told them to get organised, approach his ministry and government for support.

"Get the boss of the cooperatives bank, the one that killed it to pick up the remaining rouges, work with all of you to have the bank revamped," he said.

He was speaking on behalf of the President to millions of young people and co-operators who staged in Jinja to celebrate the International Cooperatives Day. The celebrations attracted youth from Nwoya, supported by AAU's YESSEN project (Youth Empowerment for Sustainable Self-Employment and National Development), among others.

Cooperators however blamed the slow growth of the sector on rampant corruption, which they said is a charater trait of most SACCO chairpersons and their boards. The Minister Of Trade and Cooperatives Amelia Kyambadde however urged them not to lament but to rejoice the great miles stones, among them having a Ugandan as the head of African Confederation of Cooperative Savings and Credit Association- Ms.Josephine Nabuyungo, the first Uganda chairperson.

In Uganda, cooperatives contribute 2.9 percent to the national GDP, while in Kenya over 40 percent. Ugandans were urged to work hard and be like Kenya, to be able to influence governance.

The Women Rights to Land, Peace and Justice Project in Northern Uganda with support from Australia NGO Corporation Program under DFAT supported a policy dialogue on women with disability.

Key gaps on access to justice for Persons Living with Disability (PLWD) were articulated by the MP for PLWDs Hon. Safia Nalule Juuko which included lack of friendly facilities for PLWDs including in courts, failure by government to employ sign language interpreters, high costs of equipment and thus lack of prioritisation of PLWDs budget at

regional levels as parliament continuously fails to appropriate funds for disability despite annual submission of budgets by Equal Opportunities Commission.

They also pointed out the unfair clauses in the law; "there are even flaws in the existing laws especially the penal code which refers to some categories of disability as imbisels. This is very wrong for justice," She noted

On a positive note, we were informed that Parliament has established a Parliamentary Checklist on Human Rights which is meant to assess the level of adherence to human rights standards including rights of disa-

bled persons.

The meeting promised to ensure that the following are achieved; Re-introduction of the Mental and Psychosocial Disability Bill that was withdrawn from parliament and fast track the Elderly Persons Bill by Ministry of

"What is needed is to have anti FGM advocates is a buy in from the grand mothers and grandfathers plus setting up FGM responsive clubs to empower the girl child," said another one participant.

Nivatiti said that AAU was looking forward to working with the community as partners and was ready to support community initiatives for a Zero tolerance towards FGM.
