to learn from civil society

Our Country Director appeared on the popular talk show Capital Gang on 91.3 Capital Radio. The topic of discussion was the crisis in political parties in Uganda with a specific focus on the ruling National Resistance Movement (NRM) and the largest Opposition -

Forum for Democratic Change (FDC). The CD observed that the crisis of political parties is a crisis of contemporary politics in Uganda as it reflects deeper problems Uganda faces. These include the centralization of power in the executive and within parties, personal rule being stronger than

institutional cover, weak citizen engagement in government and party processes, thus alienating parties from ordinary citizens and

the elite. Finally, he analysed the challenge of transition, especially from one leader and order to another. On the question of transition, the CD argued that this is the post critical question for parties and Uganda as a whole. Both the NRM and FDC are struggling with the question of transition while the older parties Democratic Party (DP) and Uganda People's Congress

(UPC) are stagnating because of a failed or protracted transition
