The AAU team, led by the Manager; Program Development, Simon Peter Wolumeli explained the ActionAid theory and way of work to the guests. He emphasized that ActionAid works with existing structures to engage the public officials and institutions to respect civil liberties and be accountable for provision of quality and timely social and judicial services.

The AAU team also spoke about the Information, Voice and Accountability project funded by DGF and how it had prepared ground for the new project; Harnessing Citizens Imagination, Power and Agency for Greater Institutional Accountability also funded by the DGF.

During an interaction with the District local government officials of Amuru and Gulu, the DGF team was informed that as a result of the work of AAU with funds from DGF, Amuru district has registered an improvement in the quality and quantity of service delivery.

"The Local Government staff used to reside in Gulu. They would travel every day to go to work in Amuru. They were usually late and left office before the official closing hours to travel back. The local youth rose up in protest. Today, all our staff reside in Amuru", noted the LCV Chairperson of Amuru.

The DGF team also met with community and Activista members from Nyowa and Gulu. The Activista team informed the meeting that as a result of the inspiration and empowerment of the DGF funded project, they were able contest for Political offices in the past General Elections.

"Today, we make up 75% of the political leaders in Amuru", stated the youth.

Mellisa and Lucy were impressed with the feedback they attained.

"Our expectations have been surpassed. Thank you for the great work"; stated Mellisa, cautioning AAU to come up with risk mitigation measures to check on the threat and intimidation that they encounter as they go about their work.

Human Rights Report pins Uganda Police!

For the 10th year in a row, the police have been pin-pointed as the leading abuser of human rights in the country by the government agency charged with tracking rights' violations.



The Uganda Human Rights commission report fingered the police on the abuses of Human Rights. Unforunattely, the Police Spokes person could not comment on the report. He instead asked for more time to scrutinize the report.

The Uganda Human Rights Commission (UHRC) 18th annual report indicates that 385 of the 760 complaints registered in 2015 were against the police, representing over 50%t of the complainants that checked into UHRC to file grievances.

Out of the 486 complaints registered against the police, 219 were on the violation of the right to personal liberty (detention beyond 48 hours) while 200 were on torture, cruel, inhuman or degrading treatment.

The report indicates that complaints of torture or cruel, inhuman and degrading treatment or punishment were the highest at 345 in 2015.

James Ameda, the Fundraising Coordinator who represented AAU at the launch informed the Weekly that the

report indicated a notable reduction in the number of complaints registered against most security agencies in 2015 apart from the Uganda Police that remains unchallenged.

The chairperson of the commission, Meddi Kaggwa, said that the failure of police to address human rights concerns has returned to haunt the institution for another year.

As a Human Rights Based Organisation, ActionAid will make reference to the report to roll out a campaign against police brutality in the country.
