




## Join the campaign to stop MP-Greed!



Today, I will not write captions but will allow the photos to speak for themselves. Join the campaign to put an end to the greed of our legislators. Write a message with your legislator's name on it and post it on Facebook and twitter. You can even put it on your car.

Together, we can attain tax justice in Uganda.

Yesterday, the ActionAid Country Director, Arthur Larok joined CSOs and individuals interested in promoting a fair and progressive tax regime in Uganda to issue a statement calling on the HE the President of Uganda to stand by his earlier position that MPs allowances should be taxed under the Income Tax (Amendment) Bill 2016. According to the CSOs under their umbrella body Tax Justice Alliance Uganda, the exemption of MPs' allowances from tax, would lead to an annual loss of over UGX 49 billion in revenue collection.

"This move by the MPs to exempt themselves from taxation is discriminatory, all other citizens pay taxes on their allowances including the medical workers, teachers and the private sector entities. Lunch allowances for medical workers and sitting allowances for district councilors are taxed why not MPs," Julius Mukunda, the Coordinator Civil Society

Budget Advocacy Group (CSBAG) asked.

Despite the President rejecting the Income Tax (Amendment) Bill 2016 in May this year, on November 15, 2016 Parliament defied the President, and returned the Bill to Museveni, with a proposal to exempt the MPs' allowances from taxation. In his May 2, 2016 letter to the speaker of Parliament Rebecca Kadaga, the President rejected the Bill saying the move by MPs to exempt themselves from taxation was not politically and morally correct.

Prior to that, Parliament had passed the Income Tax (Amendment) Bill with Section 21 (1) of the Income Tax Act, Cap 340 amended to exempt the employment income of members of Parliament, except salary from taxation. The decision provoked public outrage.

However, considering the motion for a resolution of parliament to reconsider the Bill on Tuesday November 15, the MPs across the political divide upheld their earlier stand, arguing that their salaries are already being taxed, thus no need for further taxation.

The CSOs have since launched a massive mobilization campaign to say no to the MPs' stand.

"We are going to mobilize masses to say no to this move by the MPs, if they insist they are not paying taxes, it should cut across, even doctors, teachers, local leaders should not have their allowances taxed," Imelda Namagga, a Senior Programs Officer Uganda debt network said

In the campaign, the CSOs want the youth, local council leaders and all taxpaying Ugandans to petition the President and the Prime Minister Ruhakana Rugunda, about the tax injustice by the MPs.

Early this year, ActionAid and other CSOs through their umbrella body Civil Society Budget Advocacy Group (CSBAG) collected over four million signatures, asking the president not to assent to the Bill, which he did.

Unfortunately, as Per the parliamentary rules of procedure, if the president rejects the Bill for the second time, the rules empower the House, to pass the Bill into law during the third time of consideration, without the President assenting to it.

The time is now for you and me to stand up and say no to this selfish move by the legislators.

## AU staff Reflection Action Skills re-kindled!

Last week, 20 ActionAid staff convened in Kalangala for a five day meeting to revitalize the practice of Participatory Methodologies with in ActionAid and its partner Organisations.

The meeting was organised to enhance understanding and practice of participatory methodology and learning processes among ActionAid and partner organisation staff. This will rejuvenate the operations of Reflection-Action circles in the community where ActionAid operates.

During the highly interactive sessions, participants reflected on the application of the Human **Rights Based Approach (HRBA)** and its relation to Reflection Action. Participants shared successes and challenges encountered while using the approach and this enabled deeper learning on the use of the approaches.

To boost the understanding of the Reflection Action Methodology, participants were introduced to basic tools to be used in analysis of people's situations in relation

to their Rights and power. Tools such as social audits, access and control matrix were used by the participants in practical sessions in the communities of Lwabelega, Mabigo and Nakatiba in Kalangala. This provided practical examples of the realities in the community as well as emphasizing the importance of a skilled facilitator.

The participants shared tactics on ensuring the establishment and full operation of Reflection Action Groups . At the end of the five days, staff were equipped with energy, strategies and tactics to

champion the methodology in the different ActionAid offices.

Reflection-Action is ActionAid's harmonised participatory methodology. Within a Reflection-Action process, AAU is able to facilitate comprehensive analysis by people living in poverty, of power relations, Human Rights, vulnerabilities, actors and institutions among others. The process starts from community analysis of their own context and builds into a cumulative way, looking at the connections between local, national and international levels. Reflection-Action is thus the bedrock for building people's agency, starting with their own conscience as this is key to successful implementation of ActionAid's human rights based approach.

## ActionAid Launches model Girls' Dormitory

ActionAid officially handed over a Girls' dormitory to Mulabana Primary School in Kalangala last week. The dormitory was constructed to address the challenges that girl children on the island district face in trying to access quality public education.

"The girls have been walking long distances to and from school. In some cases, girls travel from one island to another in boats amidst the waves to access school. By the time they get to school, they are too tired and soaked in water. This forces many of them to drop out of school at a very early stage", observed Edmond Olowo, the Program Officer in the ActionAid Kalangala office.

The dormitory facility was constructed as a model to Kalangala District Local Government as one of the strategies to improve girl child enrolment and retention in school as well as completion. The District Education Officer, Mr Nseko Emmanuel thanked Action-Aid for the investment and the challenge to the local government.

"The dormitory is going to address the risks around children traveling from one island to another to get to school and provide a conducive Iearning environment for the girls" he said.

He further commended ActionAid for initiating the school feeding program as this has resulted into improved performance and increased enrolment and retention in schools.

Richard Olong, the Manager of Partnerships and Capacity building at ActionAid emphasized that ActionAid is committed to working towards the realisation of quality public education for Ugandan pupils especially the girl children.

The Chief Guest, Mr Lugoloobi William who is the LCV Chairperson of

Kalangala Islands commended ActionAid for its contribution to the development of the district and pledged to allocate resources to equip the dormitory with beds as well as invest in constructing dormitories in other schools.

The parents of the school handed over a gift to ActionAid to express their gratitude to the organisation.
