Former Ethics and Integrity Minister and Human Rights Activist, Hon Miria Matembe last Thursday advised government to build ethics and integrity among public servants in order to kick corruption out of the country.

While speaking at the homecoming ceremony for the 4th Anti- Corruption Caravan which was organized ActionAid with funding from the Democratic Governance Facility, Matembe emphasized that corruption tendencies continue to exist in the country because some civil servants have no integrity.

"The underlying factor for corruption in this country is breakdown of moral values and integrity. This breakdown has made many Ugandans modern thieves and very inhuman." Said Matembe.

Angelina Osege, Woman Member of Parliament for Soroti and Chairperson Public Accounts Committee advised that corruption cases should not only be registered by civil society organizations but also reported such that necessary actions can be taken. Osege added that the public has a big role to play in the fight against corruption. She urged all citizens to resist, avoid, and boycott the corrupt such that they become social mis-fits.

However, Jossy Jules Rwereeza, Director Education and Public Awareness in the IGG's office cautioned that such reports should be made in good faith without malicious intentions. He added that the office has measures to protect the identity and confidentiality of whistle blowers.

He also said that the country will not collapse because of the corrupt individuals but those who see it and simply keep quiet about it.

Matembe also advised that administrative and punitive measures should be adopted when punishing corrupt people.

"Corrupt officials should be removed from public offices and brought to shame. Corruption She a should be made extremely risky such that whoever takes part in it suffers untold consequences" she appealed.

She concluded by calling upon young people to serve their purpose in their generation and make a difference in their country.

In a period of 7 days, the Anti- Corruption Caravan registered a total 72 corruption cases in the North and North Eastern regions of the country alone. These will be forwarded to the IGG's Office for further investigation and eventual prosecution in the anti-corruption court.

Ms Jane Abodo from the DPP's office assured the audience that once the cases reach the Anti-Corruption Court, the Public should be assured of Justice.

The SURGE project is working to contribute to reduced incidences of GBV by supporting the development of a continuum of care and an effective policy environment

for scaling up community, government and national processes for the prevention and response to GBV in 10 target districts by 2020. Women and girls in the districts of Nebbi, Gulu, Lira, Amuru, Mubende, Kampala, Pallisa, Kumi, Kween and Katakwi are expected to benefit from improved GBV response and prevention services during this period.
